**Retrofit Allison Input Shaft to 2001-2004 Transmission**

Allison 5-speed transmissions were built with 2 different types of input shafts. The 2001-2004 shaft has a small bearing (Image “C”). The 2004.5-2005 shaft has a large bearing (Image “D”). (SEE PHOTO BELOW)

The PPE Billet Shaft uses the large, late-model bearing, which can be retrofitted to the early transmission by machining the clutch hub. The early hub (Image “A”) has a raised thrust surface (Marked #1) that must be machined flush to the stepped surface (Marked #2). By removing approximately .068” - .072” the early hub will then be the same as the late model hub (Image “B”). (SEE PHOTO BELOW)
