INSTALLATION INSTRUCTIONS:

- 1) Remove original clutch pack.
- 2) Install Stock Apply Plate with springs (verify vent hole is in the 12 o'clock position).
- 3) Begin placing the C4 clutch stack with a .085" Friction Plate.
- 5) Next install a .098" steel plate. Followed by a .085" Friction Plate.
- 6) Next install a .068" steel plate. Followed by a .085" Friction Plate.
- 7) Next install a .098" steel plate. Followed by a .085" Friction Plate.
- 8) Next install a .068" steel plate. Followed by a .085" Friction Plate.
- 9) Next install a .068" steel plate. Followed by a .085" Friction Plate.

******Special Note - Be careful to maintain slot alignment for all Kolene® Steel Separator Plates.******
