

CONTENTS:

- (1) Heavy-Duty Cast Aluminum Transmission Pan
- (1) Removable, replaceable filter (installed)
- (1) One inch Neodymium magnet equipped drain plug (installed)
- (1) 1/8" NPT plug (installed)
- (13) M6 x 1 x 35mm Allen head bolts
- (13) M6 flat washers

INSTALLATION

- Step 1. Vehicle off. Engine cool.
- Step 2. Remove crossmember.
- Step 3. Loosen stock pan bolts to allow fluid to drain. Recycle fluid.
- Step 4. Remove pan. Retain stock gasket.
- Step 5. Thoroughly clean mating surface.
- Step 6. Install stock gasket on PPE Trans Pan flange. Tighten filter screws if necessary.
- Step 7. Mate Pan to housing surface and install two bolts to hold Pan in place. Finger tight for now.
- Step 8. Install remaining bolts. Check stock gasket fitment.
- Step 9. Tighten in a crossing pattern as shown. Final torque spec: 8-10 ft lbs.
- Step 10. Reinstall crossmember.
- Step 11. Add recommended fluid. Start engine. Check for leaks.
